As a result, the merged financials have been prepared for the current year and previous year. The financial results for the prior quarter/period of current year and previous year have been restated to reflect the impact of the merger. Consequently, all figures have been restated to present the performance of the combined entity and in conformity with Indian Accounting Standards with effect from 01.04.2024.
